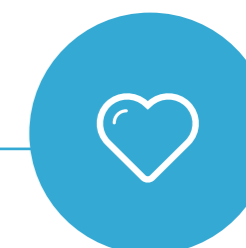
INNOVATION

VISION

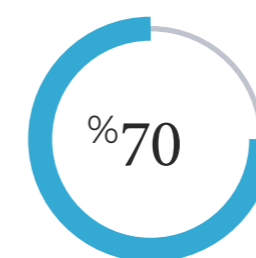

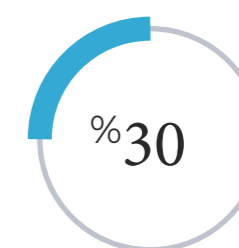
